The July expenses totaled (\$336,086.28). The July in-and-out transfers were \$482,796.87. The July net balance change was \$1,108,231.87. As of July 31, 2024 the District's ending balance was \$7,334,945.36. A motion was made by Trustee Juister and seconded by Trustee Rutzen to accept the Treasurer's Report as presented.
