A regular meeting of the North Maine Fire Protection District Board of Trustees was held on Wednesday, September 14, 2022 at 7:00 p.m. in the North Maine Fire Station located at 9301 N. Potter Road, Des Plaines, Illinois 60016, pursuant to notice.

CALL TO ORDER: The meeting was called to order at 7:00 p.m.

PLEDGE OF ALLEGIANCE: The Board stood and recited the Pledge of Allegiance.

APPROVAL OF MEETING MINUTES: August 10, 2022 Regular Meeting Open Session Minutes: The Board reviewed the August 10, 2022 regular meeting minutes. A motion was made by Trustee Rutzen and seconded by Trustee Neal to approve the August 10, 2022 regular meeting minutes as written. Motion carried unanimously by voice vote.

PUBLIC COMMENT: There was no public comment.

TREASURER'S REPORT: August 31, 2022 Treasurer's Report: The Board reviewed the Treasurer's Report for the period ending August 31, 2022. The District's beginning balance as of August 1, 2022 was \$4,078,012.97. The District received deposits during the month of August in the amount of \$182,209.36. The District's expenses for the month of August totaled (\$377,888.30). The August in-and-out transfers were \$527,799.34. The net balance change for the month of August was (\$195,678.94). The District's total ending balance as of August 31, 2022 was \$3,882,334.03. A motion was made by Trustee Neal and seconded by Trustee Rutzen to accept the Treasurer's Report as presented. Motion carried unanimously by voice vote.

ATTORNEY'S REPORT: Attorney Lamb informed the Board that the CPI has increased by 7% which will affect the Fund's Tax Levy and noted the Board will have to hold a Truth in Taxation hearing to discuss the increase. The Board noted they will hold budget hearing prior to their November 9, 2022 regular meeting followed by a the regular meeting which will hold a Truth and Taxation hearing. Attorney Lamb also informed the Board that Cook County has not yet been issuing tax monies and Board may request a Tax Anticipation Warrant loan from their local bank if needed. Updates will be provided as they become available.

FIRE CHIEF AND TRUSTEE REPORTS: Chief McKay informed the Board of the following:
