**PUBLIC COMMENT:** Investment Report – Sawyer Falduto Asset Management, LLC: Investment Performance Report: Mr. Sawyer presented the Investment Performance Report for the period ending May 31, 2022. As of May 31, 2022, the investment gain is (\$10,876) for an ending market value of \$2,684,938.00. The current asset allocation is as follows: fixed income at 99.8% and cash equivalents at 0.2%. Mr. Sawyer reviewed the Market Commentary, Equity and Fixed Income Portfolios, Credit Rating Report and Transaction Ledger Report with the Board.

**TREASURER'S REPORT:** May 31, 2022 Treasurer's Report: The Board reviewed the Treasurer's Report for the period ending May 31, 2022.
