A regular meeting of the North Maine Fire Protection District Board of Trustees was held on Wednesday, June 12, 2024 at 7:00 p.m. in the North Maine Fire Station #1 located at 9301 N. Potter Road, Des Plaines, Illinois 60016, pursuant to notice.

CALL TO ORDER: The meeting was called to order at 7:01 p.m.

APPROVAL OF MEETING MINUTES: May 8, 2024 Regular Meeting Open Session Minutes: The Board reviewed the May 8, 2024 regular meeting minutes. A motion was made by Trustee Rutzen and seconded by Trustee Juister to approve the May 8, 2024 regular meeting minutes as written. Motion carried unanimously by voice vote.

TREASURER'S REPORT: May 31, 2024 Treasurer's Report: The Board reviewed the Treasurer's Report for the period ending May 31, 2024. As of May 1, 2024 the District's beginning balance was \$6,624,469.96. The District received deposits during the month of May in the amount of \$166,614.61. The May expenses totaled (\$374,696.01). The May in-and-out transfers were \$342,207.26. The May net balance change was \$208,081.40. As of May 31, 2024 the District's ending balance was \$6,416,388.56. A motion was made by Trustee Juister and seconded by Trustee Rutzen to accept the Treasurer's Report as presented. Motion carried unanimously by voice vote.

ATTORNEY'S REPORT: Attorney Lamb updated the Board on legislation applicable to the Fire Protection District as well as the Pension Fund.

FIRE CHIEF AND TRUSTEE REPORTS: Chief McKay informed the Board of the following:
